# Temporary Road Closure 2025 Challenge Bathurst

The Mount Panorama Motor Racing Circuit will be closed from approximately 8am on Wednesday 19 November 2025 to approximately 6pm Thursday 27 November 2025 (inclusive), to control the movement of traffic:

i. on Mountain Straight, just above the entrance to the Paddock Camping Area; and ii. on Conrod Straight, just above Murray's Corner.

Persons wishing to gain access to the Track should enter via Panorama Avenue and Pit Straight.

Note: This access is to be used by all persons with proper accreditation wishing to gain access to the Circuit.

Barriers will be set up at Murray's Corner and Mountain Straight, security arrangements for residents to proceed to their homes will be in place.

# Public exhibition of planning proposals: 34 Busby and 50 Busby Streets

Public Exhibition of two separate Planning Proposals which seek to amend the Bathurst Regional Local Environmental Plan 2014 at 34 Busby Street and 50 Busby Street, South Bathurst.

Notice is hearby given that Council is in receipt of two separate Planning Proposals in relation to land at part 34 Busby Street (PP-2024-1001) and 50 Busby Street (PP-2024-418), South Bathurst.

Both Planning Proposals seek to amend the Bathurst Regional Local Environmental Plan 2014 (LEP) to:

- Rezone the lands from RI General Residential to R3 Medium Density.
- Increase the permissible height of buildings from 9m to:
  - I2m and I8m at 34 Busby St
    - 12m and 16m at 50 Busby St.
- Update the associated minimum allotment provisions.
- Insert a site-specific additional local provision clause to support small-scale food and drink premises on both sites.
- Insert an additional local provision clause to require detailed Development Control Plan (DCP) provisions to be in place before a development application (DA) can be considered for either site.
- Apply clause 7.6 Mount Panorama Environs to each site.
- Extend clause 5.10 Heritage Conservation over all of 50 Busby Street.

The proposed amendments seek to facilitate a greater density of dwellings on each site to support improved housing choice and diversity within the City of Bathurst.

#### **Public Exhibition**

Both Planning Proposals have now been placed on **public exhibition** for a period of 28 days **from Monday 17 November 2025 to Monday 15 December 2025**.
