Draft Policy - Local Government Elections Caretaker Period Policy

In the lead up to Local Government elections, Councils have restrictions placed on them. The aim of the Policy is to ensure the Council, community and staff are aware of what Council can and cannot do during the caretaker period prior to a Council election. The draft Policy largely reiterates the provisions of the Local Government (General) Regulations 2021, and in particular Clause 393B. The draft Policy reflects the previous practices of Council, although now formalised in a Policy.

Draft Policy - Roadside Stalls and Street Vending

Council has reviewed its Policy "Street Vending and Sale of Fruit and Produce from Orchards and Market Gardens" and has determined that the Policy no longer reflects current definitions, approval pathways and industry guidelines. Council therefore intends to repeal the "Street Vending and Sale of Fruit and Produce from Orchards and Market Gardens" Policy and replace it with a new "Roadside Stalls and Street Vending" Policy. The aim of this new Policy is to provide guidelines for Council, producers and sellers for the sale of locally grown produce and other products from the roadside, from a public place or from a farm gate premises.
