#### 1 BLUE HELIOTROPE (18.00004)

**Recommendation**: That Council contribute \$5,000 to Upper Macquarie County Council to be used in the control of Blue Heliotrope.

**Report**: During 2009/2010 Council contributed \$25,000 towards the control of Blue Heliotrope by Upper Macquarie County Council. This contribution allowed Upper Macquarie County Council to commence a control/eradication program for this weed.

During the preparation of the Management Plan 2010/2011 this expenditure item was missed from the budget process. In order to assist Upper Macquarie County Council with a follow up program for this year it is requested that Councillor's provide \$5,000 to Upper Macquarie County Council and that it be funded from Bathurst Regional Council Weed Control Program which has a vote of \$20,000 and an expenditure so far this year of \$0.

<u>Financial Implications</u>: There are no overall changes to the budget as the total expenditure on this item will remain at \$20,000.

**Report**: Council has received a request from Bathurst Panorama Chorus for financial assistance to assist with the hire charges for the Bathurst Memorial Entertainment Centre for the 20th Anniversary Concert. A copy of the request is provided at **attachment 1**.

This concert will include performers who have been participating in the recent guest program. The concert will also highlight the talent of local students with performances by Cirkus Surreal from Denison College Kelso High campus and students aged 8-15 years from the Ali Lavis Suzuki Piano Studio.

As you are aware, Bathurst Panorama Chorus is a not-for-profit community group. The Chorus currently has 31 active members. The Chorus regularly participates in community and cultural events and has represented the Bathurst Region with distinction in national and international competitions during its 20 year history.

The aim of the concert is to celebrate the Chorus' history and achievements and promote the artistic talents of local youth. The concert will contribute to fund-raising for the ongoing operations of the Chorus.

<u>Financial Implications</u>: Council's BMEC Section 356 vote has been exhausted therefore this funding will need to come from the General Section 356 Donations which currently has a balance of \$26,791.70.

- An industry forum in mid February focussing on aged care issues in light of the Productivity Commissioners recent report "Caring for Older Australian's". the day will explore the implications for Bathurst, local providers and seek to identify ways in which services can be delivered more effectively within the community. we would anticipate approximately 40 people would attend this day which would attend this day which would run between 9am and 4pm.
- A "Seniors Expo" to be held during Seniors Week 2012. the expo would be open to the general public between 9am and 3pm and will include both information sessions and general information from local providers. Typically, these events draw between 100 and 200 people.

Bathurst Health Council have also asked that Council provide food/light meal for both these events.

As Council is providing a meeting venue at a cost of \$917 the further provision of food should be the responsibility of Bathurst Health Council. Should Council provide the cost of food this would approximately be \$700.
