# 1 UPPER MACQUARIE COUNTY COUNCIL DELEGATES (18.00172, 11.00005)

**<u>Recommendation</u>**: That Council appoint two delegates to the Upper Macquarie County Council.

**<u>Report</u>**: Council received notice from the Director General, Department of Local Government that a proclamation was published in the Government Gazette of 23 May 2008 to reduce the number of Bathurst Regional Council's representatives on the Upper Macquarie County Council to two representatives. This became effective following the 13 September 2008 local government election.

The proclamation is dated 14 May 2008 and the schedule is as follows:

- 1. Reducing the number of members to be elected to the governing body of Upper Macquarie County Council by Bathurst Regional Council from four to two.
- 2. Reducing the number of members to be elected to the governing body of Upper Macquarie County Council from ten to eight, so that each of the constituent member councils of the local government areas of Bathurst Regional, Blayney Shire, Lithgow City and Oberon shall each have two representatives on the County Council; and
- 3. Declaring that the change to the constituent membership of Upper Macquarie County Council shall come into effect after the ordinary local government elections held on 13 September 2008.

Appointment of delegates to the Upper Macquarie County Council is for the period 2012-2016 (4 years)

To act in accordance with authority delegated by the Roads & Maritime Services, NSW to:

- Reduce hazards and accident potential for all road users.
- Reduce any adverse impacts of traffic on the surrounding environment.

The "Councillors Meetings with Community Groups/Representatives" are informal, by appointment, and on a scheduled basis to maximise opportunities for organisations and members of the public to raise issues with Councillors.

In addition, the sessions also allow invitations to be extended to specific community groups and others currently not involved with Council to ensure Council has an updated, accurate and focused position on all facets of the Bathurst community. The Councillors Meetings with Community Groups/Representatives allows for meetings to maximise the potential for community involvement.

The issues to be discussed are of community interest with individual concerns, for example a rate payer's excess water charges being a matter to be addressed at the General Manager or Mayor's level followed by a report to Council if required.

#### **Economic Development Committee**

To assess and recommend to Council on Economic Development inquiries to Council.

#### National Framework for Women in Local Government

To create Councils and communities where women feel able to fully participate and share their skills, knowledge and experience.

To work towards harrassment-free, participative Councils where opinions and differences are respected.

To develop a climate of understanding among Councillors, CEO's/General Managers and senior staff of the need for the initiatives in this Framework and to enlist their support.

Where women choose women-only training and networking, to gain acceptance and support of their participation in these activities.
