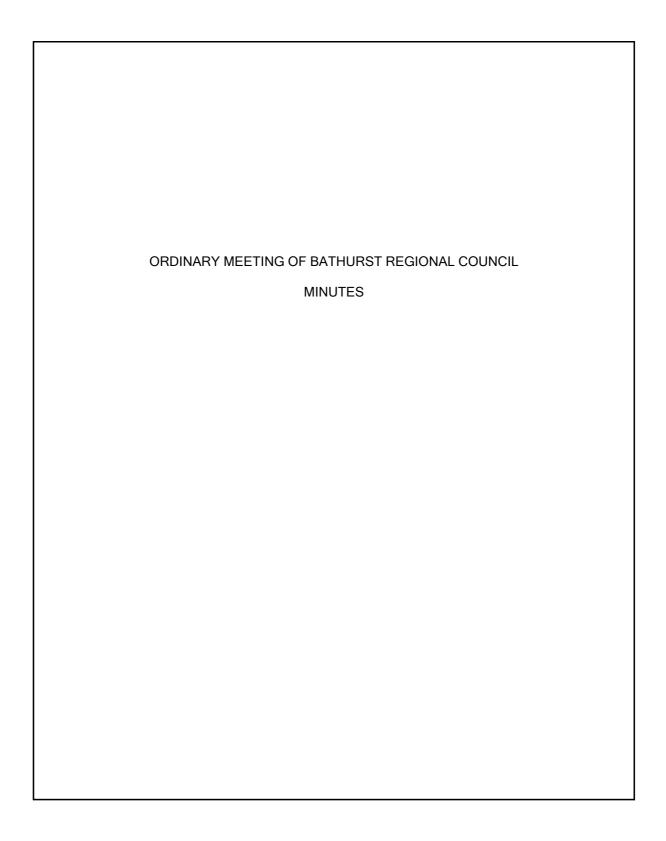

#### **Report:** What is a Section 94 Development Contribution Plan?

Section 94 Development Contributions are levied on developers when land is developed (eg subdivided) to contribute towards the provision of new or improved infrastructure to service the additional population. Section 94 Development Contributions aim to be fair, tangible and proportioned to the population increase creating the demand for the improved facilities. It is important to note that Council will only collect a portion of the total funds required to complete all of the works identified within the Plan.

#### Section 94 Development Contributions Plan - Eglinton Open Space and Drainage

In the case of the Eglinton Open Space and Drainage Contribution Plan, Council requires a contribution towards the provision, extension or embellishment of open space and drainage works that will be required as a consequence of development in the area or that have been provided in anticipation of or to facilitate such development.

#### Section 94 Development Contributions Plan - Roadworks (New Residential Subdivisions)

In the case of the Roadworks – New Residential Subdivisions Development Contributions Plan (this Plan), the contributions which are collected will be used to fund various road upgrades and intersection treatments within the suburbs of Windradyne, Llanarth, Abercrombie and Eglinton. The projects which have been included are identified within the Section 94 Development Contributions Plan.

#### Why is Council preparing Section 94 Development Contributions Plans?

Copies of the Section 94 Development Contributions Plans are at attachment 1 and 2.

#### Section 94 Development Contributions Plan - Eglinton Open Space and Drainage

Council recently adopted the Planning Proposal for the expansion of Eglinton, which will see approximately 612 additional allotments created together with approximately 20 hectares of open space. Additional open space is required to service the expanded village and to provide a buffer between the village and adjoining rural land. Council has an obligation to compensate the various landowners for the open space that will be zoned 6(a) - Local Recreation.

Additional residential development will increase the level of stormwater being generated from the village. The construction of rock ramps within the drainage depression west of Eglinton and within Saltram Creek to the east of Eglinton will reduce the erosion within the drainage line and Saltram Creek.

#### Section 94 Development Contributions Plan - Roadworks (New Residential Subdivisions)

Council reviewed its Section 94 Development Contributions Plan in response to the recently adopted Planning Proposal for the expansion of Eglinton, which will have approximately 612 additional allotments to which the Plan should apply. Council must ensure that the roadworks and intersection upgrades related to the expansion of Eglinton are included in the Plan.

Council also took the opportunity to review the roads identified in the Plan through the subject area together with the intersections identified and the costs of construction. The Section 94 Development Contributions Plan was originally adopted by the former Bathurst City Council in 1997. Council has an obligation to periodically review its Section 94 Development Contributions Plans under the Environmental Planning and Assessment Regulations 2000.

#### **Community consultation**

Council placed the Contribution Plans on public exhibition for a period of 6 weeks from 18 August 2012 to 1 October 2012. Affected landholders were notified of the exhibition period and notices were placed in the Western Advocate. During this time, Council did not receive any submissions in relation to the Plans.

#### **Conclusion**

Council has prepared an amended Section 94 Developer Contributions Plan - Roadworks (New Residential Subdivisions) and a new Section 94 Developer Contributions Plan - Eglinton Open Space and Drainage in response to the Eglinton Expansion Planning Proposal. Council placed the Section 94 Development Contributions Plans on public exhibition for a period of 6 weeks and did not receive any submissions in response to the Plans.

It therefore will be recommended that Council:

- (a) adopt the amended Section 94 Development Contributions Plan Roadworks (New Residential Subdivisions);
- (b) adopt the new Section 94 Development Contributions Plan Eglinton Open Space and Drainage;
- (c) amend Council's 2012/2013 Revenue Policy to reflect changes to the amended Section 94 Development Contributions Plan - Roadworks (New Residential Subdivisions) and the new Section 94 Development Contributions Plan - Eglinton Open Space and Drainage; and

(d) give notice of the Section 94 Development Contributions Plans in accordance with Clause 31 of the Environmental Planning and Assessment Regulations and Section 94EA of the Environmental Planning and Assessment Act.

**<u>Report</u>**: The NSW Government has released "A New Planning System for NSW – Green Paper." The Green Paper broadly outlines the Government's proposed major changes in key areas of the planning system. The Government has promoted the key reforms in the Green Paper as including:

- 1. earlier community involvement in guiding planning decisions, that is at the strategic planning stage rather than at the development assessment stage;
- 2. placing more emphasis on preparing good policies upfront to guide growth and development;
- 3. reducing red tape and delay in the development assessment process;
- 4. ensuring infrastructure is planned and delivered;
- 5. promoting a "can do" culture in the planning system; and
- 6. providing greater access to information about planning policies and decisions.

Local Government submissions on the Green paper were due on 5 October 2012. Given the timing of the election it was not possible to report Council's submission to Council prior to its lodgement with the Department of Infrastructure and Planning. Council's submission is therefore provided at <u>attachment 1</u> for information.

Whilst reform of the planning system is supported along with support to increase and improve strategic up-front planning, Council's submission highlights a number of key concerns as follows:

- 1. The Green Paper is clearly very metro centric. Much of the reform proposed may not be as relevant to regional and rural areas, particularly large spatial Local Government Areas such as the Bathurst Region.
- 2. The Green Paper proposes a high level of regional strategic planning. Local planning appears to be lost in a web of regional plans.
- 3. The Green Paper appears to dilute the planning powers of local government.

Of ongoing concern to Council's Environmental Planning & Building Services Department is the need for the State Government to move away from a one size fits all approach to planning in NSW.

Council's staff and Heritage Advisor have been putting together plans to hold a seminar in November this year on "How to prepare and understand a Heritage Impact Statement".

It is hoped that Council will be able to attract a speaker from the NSW Heritage Office to talk about "Communicating why heritage matters - writing value statements". Staff recently attended the NSW Heritage Network Seminar in Sydney and this presentation provided a wonderful insight on how to write value statements about heritage significance and impact in plain english.

Council's Heritage Advisor will then give a presentation on how to prepare a Heritage Impact Statement. This presentation will include practical examples and will also form the launch for new guidelines prepared by Council's Heritage Advisor to assist applicants better identify and examine the heritage impact of proposals.

The seminar will be targeted towards heritage consultants and designers who prepare Heritage Impact Statements, Council staff who assess them and local interest groups, such as the National Trust, who seek to provide comment on development proposals. The seminar will be held under the Central West Heritage Network banner and invitations extended to neighbouring Council areas.

All Councillors are invited to attend the seminar. Details will be provided closer to the date.

#### 6 BATHURST CONSERVATION AREA MANAGEMENT STRATEGY (13.00035)

**<u>Recommendation</u>**: That the information be noted.

**<u>Report</u>**: At Council's meeting held 26 September 2012, a report was requested in relation to the Bathurst Conservation Area Management Strategy (BCAMS). This report is timely to assist new Councillors understand the existing BCAMS system as adopted within the Bathurst Regional (Interim) Development Control Plan 2011 (DCP).

BCAMS is a methodology developed by Council staff and Council's Heritage Advisor. The Strategy is unique to the Bathurst Regional Council area and is not linked to any state legislation. Council's current DCP incorporates the methodology and requires Council to consider the BCAMS rating in relation to applications for the demolition of a building.

The principle objective of BCAMS is to provide clear and concise information on the value of individual buildings which form part of the Bathurst City Heritage Conservation Area. The rating system is based on the:

- 1. the buildings integrity;
- 2. its streetscape rating; and
- 3. its heritage significance.

The rating system and the rating value for each component is summarised in the tables below. The total rating ranges from 10, being the most significant buildings down to 0, being the least significant buildings.

The BCAMS rating system is only relevant to buildings which face a public street as an integral part of the rating is how the building contributes to the streetscape. Thus BCAMS is not relevant to applications for demolition of outbuildings such as that recently considered for 62 Morrisset Street.

BCAMS aims to provide Council with objectivity in defining the value of a building. That value can then be considered in applications involving the demolition of a building. It should

<u>not</u> however be the only matter taken into account. Council's DCP requires applications to include Heritage Impact Statements. Such statements vary in their content but generally include information on the structural integrity of the building and its social history. So, for example, Council might receive an application to demolish a building that rates very highly in relation to BCAMS but for which demolition may remain the only option given the structural adequacy of the building. Alternatively, BCAMS might rate a building quite low but investigation of its social history links the building to a significant person, eg Ben Chifley, and for this reason demolition may not be supported.

BCAMS is one of a set of tools to assist Council make sound development decisions that affect the regions heritage.

#### 7 FORMER BATHURST SALEYARDS: FINAL REMEDIATION REPORT (22.12383)

**<u>Recommendation</u>**: That the information be noted.

**<u>Report</u>**: Located at the corner of Vale and Lloyds Roads, South Bathurst, the site operated as a saleyards from 1889 to 2009. Following decommissioning of the site Council engaged Parsons Brinckerhoff to undertake a Phase 2 Environmental Site Assessment in 2010. This assessment determined that there was some low level contamination associated with septic systems that previously existed on the site. A Remedial Action Plan (RAP) was developed which outlined the actions required to remediate the site.

Council engaged Envirowest Consulting to undertake the remediation in 2011 which was completed as per the RAP. However fibrous cement sheeting was uncovered as part of the works which was later determined to be asbestos containing material (ACM). Further assessment determined that ACM was present in two discrete locations. Envirowest Consulting developed an additional RAP to deal with the asbestos.

Council engaged Envirowest Consulting to remove the ACM in 2012. Asbestos and surrounding soil was removed from the two locations and a visual clearance inspection was undertaken across the remainder of the site by an Environmental Hygienist. In September 2012 Council received a site validation report stating that site remediation has been completed and that the site is suitable for future commercial land use.

A report will be prepared in the coming months with a recommendation on how Council should proceed with the use of the site.

**Financial Implications**: The remediation of the former Bathurst Saleyards was funded through existing allocations.



**<u>Report</u>**: Council has been approached by Central Tablelands Woodcraft to extend their workshop facilities at Learmonth Park, Bathurst.

The proposed extension is shown at **<u>attachment 1</u>** and will include an extension of 72m<sup>2</sup> which will be used for new equipment to improve their wood turning facilities.

This organisation is located at Learmonth Park in a Council owned building and supplies a community service for many people to come to that facility and learn about woodcraft and share a common meeting place with like interested people. The club has been operational at Learmonth Park for approximately 10 years and since their initial move to the facility have had two previous extensions, one of 50m<sup>2</sup> and another of over 100m<sup>2</sup> to accommodate the growth.

Council has been advised that the proposed extension will cost approximately \$21,000.

Central Tablelands Woodcraft have requested the following funding source:

- 1. Contribution from Central Tablelands Woodcraft \$5,500
- 2. A loan from Council of \$6,000 at the current borrowing rate to be repaid over a 10 year period.
- 3. A contribution from Council of 50% of the construction costs being \$10,500.

As this organisation has a long history with Council and is a financially secure organisation it is recommended that Council enter into a funding agreement with them for the construction of this shed.

Further, it is recommended that Council contribute \$10,500 from Land Development Reserve and make available a loan of \$6,000 at the current borrowing rate over 10 years.

**<u>Financial Implications</u>**: Council's contribution of \$10,500 will be funded from the Land Development Reserve.



Successful recipients will be notified that the receipt of these funds does not exempt their organisation requiring development approval for their proposed works. 





- These included a young girl who was intoxicated as a result of drinking prior to the event.
- There was a young boy suspected of selling drugs at the event. The Police investigated the matter and the allegation was proved to be false.
- There were rumours being spread that young people were "stabbed with syringes" on the dance floor. These rumours were false and it was established the glowsticks at the dance party were mistaken for syringes. There was discussion about the dangerous nature of such rumours.
- There were a small number of small bottles of alcohol found hidden in the boys toilet area at the conclusion of the event.
- A de-brief has been undertaken with Security and BMEC staff to discuss strategies to deal with this situation at future events.




