#### **Recommendation**: That Council:

- (a) forward Bathurst Regional Local Environmental Plan 2014, including those amendments to the plan as outlined in this report, to the Department of Planning and Infrastructure pursuant to the Environmental Planning and Assessment Act for gazettal by the Minister for Planning, and
- (b) adopt the Bathurst Regional Development Control Plan 2014, including those amendments to the plan as outlined in this report, and note that the DCP will not come into effect until the Bathurst Regional Local Environmental Plan 2014 is gazetted, and
- (c) upon gazettal of the Bathurst Regional Local Environmental Plan 2014, repeal the following Development Control Plans:
  - Bathurst Regional Council DCP Complying Development;
  - Bathurst Regional Council DCP Exempt Development; and
  - Bathurst Regional (Interim) DCP 2011, and
- (d) adopt the Bathurst Regional Council Tree Preservation and Management Policy, and note that the Policy will not come into effect until the Bathurst Regional Local Environmental Plan 2014 is gazetted, and
- (e) note that upon gazettal of the Bathurst Regional Local Environmental Plan 2014, the following Plans will be repealed:
  - Bathurst Regional (Interim) Local Environmental Plan 2005; and
  - Bathurst Local Environmental Plan 1997 Classification and Reclassification of Public Land, and
- (f) give public notice of Council's decision in accordance with the requirements of the Environmental Planning and Assessment Act, and
- (g) notify those who made submissions of the decision of Council, and
- (h) call a division.

#### **Report**: Public Exhibition

The draft Bathurst Regional Local Environmental Plan (LEP) 2014 and draft Bathurst Regional Development Control Plan (DCP) 2014 were placed on public exhibition from 5 August 2013 to 16 September 2013. Note that the draft Plans were exhibited as being the 'draft Bathurst Regional LEP and DCP 2013'. The Department of Planning and Infrastructure have advised that they should now be entitled 'Bathurst Regional LEP and DCP 2014' to reflect the likely gazettal date of the LEP next year.

During the public exhibition period Council held 10 information sessions to provide an overview of how the draft new planning control changes may affect the Bathurst Regional community. Council's planning staff were available at these sessions to answer queries in relation to the proposed changes. These information sessions were widely publicised in the local newspaper and on the radio. Approximately 1000 letters were sent out to individuals and interest groups notifying them of the exhibition period and inviting them to attend the

information sessions. Council staff also manned a static display in the Bathurst City Centre and the Stocklands Mall and were available to answer any queries from the public.

Council received a total of 92 submissions from the public and 13 submissions from Government Departments during the public exhibition period. Members of the public who made a submission were invited to a discussion forum held on 9 October 2013. The report to the discussion forum included the public submissions received to that date. Late submissions received from the public and submissions received from the Government agencies are included at attachment 7 and attachment 8 below.

Assessment of issues raised in submissions and recommended changes to the Draft Plans

Following the discussion forum, Council staff have considered the submissions received and the issues raised. Recommendations to alter the draft Plans have been made where considered appropriate. The following list of attachments summarise the assessment process undertaken and the recommendations for changes to the draft plans.

<u>Attachment 1</u> to this report summarises the public submissions received, the recommended planning response and where appropriate, how the Plans have been altered.

<u>Attachment 2</u> to this report summarises the submissions received from Government Departments, the recommended planning response and where appropriate, how the Plans have been altered.

Attachment 3 to this report provides a detailed response to the Bathurst 2036 Heritage Action Network's submission to the draft Plans. The table illustrates the recommended planning response to their submission and, where appropriate, how the Plans have been altered.

A large number of the submissions requested changes to the draft Plans which are recommended to be supported by Council. In many circumstances those submissions are supported by recommendation/s from Council's landuse strategies, environmental studies, or the heritage study.

Key changes recommended to be supported from those submissions include:

- Alteration to the configuration of open space within the Kelso expansion area.
- Additional permitted uses on some rural properties to enable smaller lot clustered subdivisions, and at the former St Vincent's Hospital site to enable child care centres and seniors housing.
- Altering the zone of certain lands from Recreation to Environmental Conservation.
- Extending the Heritage Conservation areas for Hill End and Rockley.
- Reviewing the building standards for Wattle Flat under chapter 7 of the DCP.
- Amended notification of Development Applications procedures for the Village of Hill End.
- Various changes to the LEP and DCP in relation to heritage matters.
- Various zoning changes consistent with Council's landuse strategies.

There have also been a number of submissions which are recommended <u>not</u> to be supported by Council. In many circumstances (with the exception of Clairvaux Lane area and Heritage subdivisions) the request made in the submission is not supported by Council's landuse strategies or the heritage study. If Council wishes to support those submissions, the landuse strategies should first be reviewed. These submissions or issues would best be addressed through a future landuse strategy review. It is anticipated that the landuse strategies will be reviewed when the Government's new Planning legislation is introduced.

The matter relating to Clairvaux Lane is directly linked to the ability to provide adequate infrastructure to the area. **Attachment 6** provides detailed information about this issue.

The matter relating to permitting rural heritage items to subdivide in order to raise funds to restore or maintain the heritage item was recommended by Council's Heritage study. Council has investigated a number of different options, including bonds, delaying the release of the subdivision certificate and covenants, but was unable to appropriately link the sale of the vacant land (with the ability to erect a dwelling) to the restoration or maintenance of the Heritage Item. It should be noted that there are a number of alternative funding methods available to the owners of Heritage Items listed on the State Heritage Register to fund major restoration works. There are a number of recent examples of local property owners successfully receiving significant grant funding to restore their properties from the NSW Government.

Council staff have also undertaken an extensive review of the draft Plans since their exhibition. A variety of minor changes have been made to the draft Plans that do not alter the intent of the Plans provisions as originally exhibited.

On the advice of Council's Environmental staff a number of Council owned properties have been zoned E2 Environmental Conservation as opposed to a recreation or rural zoning as exhibited. This is consistent with the recommendations of Council's Biodiversity Study.

Council's Recreation Section has drafted a new Tree Preservation and Management Policy for the Bathurst Region. This was initiated given the changes in the draft LEP/DCP as exhibited which will see approvals/permits required for tree removals in Heritage Conservation Areas (11 localities) and Heritage Items only.

It should be noted that Council received no adverse comments from the public to the

proposed changes to tree removal approvals/permits as exhibited in the draft LEP/DCP. The community has supported the change to require tree approvals/permits only in relation to heritage conservation areas and heritage items.

It is proposed that the new Policy will be linked to the Development Control Plan in Section 13.2 of the DCP. A copy of the draft Tree Preservation and Management Policy is provided at <u>attachment 11</u>.

The Policy establishes Council's procedures and processes for dealing with applications for the removal of trees. The majority of the policy reflects current practice and better explains the requirements of Council.

The key differences between the draft Policy and the provisions of the draft LEP/DCP as exhibited or current practices are:

- Exempt tree species the policy defines exempt trees as those tree species not highly regarded in the Bathurst Regional Council area (e.g. willows), noxious weeds and dead trees. The policy enables removal of these trees in heritage conservation areas following notification to Council only. No approval/permit is required to be issued by Council. All other tree species require approval/permit for removal where located in heritage conservation areas and heritage items.
- Tree height the Policy adopts a tree height of 9 metres as a means to ensure that all mature trees that are likely to impact on the landscape are captured by the Policy. A tree height of 4 metres was exhibited in the draft LEP/DCP and is applicable under the current tree preservation order. This has proved inefficient as trees that do not extend to/above the height of buildings are generally not those that impact significantly on the landscape, particularly in heritage conservation areas and heritage items, nor are they usually mature trees. A 9 metre height limit is the adopted building height under the new LEP for residential buildings in the heritage conservation areas. It is considered appropriate to apply the same height to trees for which approval/notification of their removal is to be obtained.

Adoption of the draft Tree Preservation and Management Policy is therefore also recommended by this report.

#### Conclusion

Whilst this report recommends a number of changes to the draft Plans, these changes are generally of a minor nature and do not alter the original intent of the draft Plans as exhibited. Re-exhibition of the draft Plans is therefore not warranted.

Changes to the draft Plans have been recommended where they are consistent with Council's landuse strategies. Changes have <u>not</u> been recommended where they are considered to be inconsistent with these landuse strategies.

The preparation of the new planning controls for the Bathurst Regional local government area has been an exhaustive task commencing with the preparation of Council's landuse strategies in 2005. The timeframe for completion has been considerably delayed as a result of:

- (a) The NSW Government's Inquiry into Rural Lands held in 2007.
- (b) The delay in the Department of Planning and Infrastructure's endorsement of the Rural Strategy.
- (c) Ongoing negotiations with the Department of Planning and Infrastructure to secure appropriate planning outcomes for the region, particularly with respect to Mount

Panorama and exempt and complying development.

Council staff are now satisfied that the NSW Government's Standard Instrument LEP can be implemented in the Bathurst Region as recommended by this report. It is likely that the process of a major review of these new plans will commence in the near future when the NSW Government introduces its new planning legislation.

It is therefore recommended that Council adopt the Plans and forward the draft Bathurst Regional Local Environmental Plan 2014 to the Department of Planning and Infrastructure for making. Note that the draft LEP will be reviewed by the Parliamentary Counsel and legal changes made to it based on their advice. Those changes will not alter the intent of the LEP as attached to this report. It is expected that the draft LEP will be made by the Minister in early 2014. At that time the draft DCP and new Tree Preservation Policy will come into effect.

<u>Financial Implications</u>: The draft new planning controls have been prepared within existing budgets and from grant funding provided by the NSW Department of Planning and Infrastructure.
