2 PUBLIC QUESTION TIME

<u>T Jones</u> – resident - Fallen trees and Tree Preservation Order: Lorimer & Braham Streets - spoke to issue of fallen trees and costs thereof and applications under Tree Preservation Order for removal of trees on his property. Had to get arborist to provide advice and over \$3,000 in costs to remove trees after first staff member said to remove and then other managers refused the recommendation. Queried process in place and conflicts and issues experienced. Had support from SES and other qualified arborists to remove trees. Will Council reimburse him?

The Mayor advised that the Director Engineering Services will review issues raised and respond to Mr Jones.

<u>T Clark</u> – O'Connell Road - over road from Scots School paddock has a lot of Yass River tussock. This needs to be removed. Also this area has a lot of kangaroos, can Council do anything about this.

The Mayor advised that issue of Yass River Tussock will be referred to Upper Macquarie County Council.

<u>G Crisp</u> – ratepayer - advised Engineering Department repainted distance signage on River Walk - thanked staff for doing this.

Raised parking issues and parking contrary to regulations, referred to letters forwarded by himself to Council. Made allegations of fraud by Council staff.

<u>R Collins – 17 Stack Street</u> - referred to June 2012 meeting re graffiti on Optus building and then the subsequent October 2012 meeting. Then spoke to Council cleaning up the building and further graffiti in December 2012. Asks why Council paid for removal of graffiti and has a bill been charged to Optus for this. Council money should not have been spent on this.

<u>P Wright</u> – Keppel Street Business/resident - advised keen to work with Council to refurbish Keppel Street between Railway Station and Machattie Park. Spoke to facilities in area, increased usage due to visitors, with enhanced railway services. Noted area has good parking, access, village atmosphere etc. Group has met to develop discussion points for Council on what could be done to the area, tabled proposal document. Issues such as trees, heritage, CBD Beautification document, parking were addressed. Would like to meet with Council to discuss the proposal so can be considered as part of the budget process.

The Mayor requested Mr Wright contact the General Manager so a meeting can be organised.

<u>Bhakti Manning</u> - ratepayer - DA processes - spoke to processes in place for development applications and their consideration. Issues such as open space, privacy, land suitability, content of LEP, DCP's amenity of private spaces were raised.

Talked of units and high density and need for open space. Last meeting the Council approved a departure from DCP, do Councillors understand their role and understand the conditions under which variations are allowable?

2 PUBLIC QUESTION TIME

Terry Murray - Cartographer - Land Property Information (LPI) - advised he was here to make Council aware of what is happening at LPI, particularly the possible privatisation. There are over 260 staff at the LPI. Concerned that the scoping study leads into a done deal. Covers LPI in Bathurst and Sydney and valuation services across the State. This is a real concern for staff. It is unfounded to say privatisation will create more jobs, already have lost 14 jobs to another Government Department in Orange. The LPI and staff spend around \$4 million per annum in Bathurst and many staff are involved in community groups. Concern if goes privatised, will cost more for the services provided to Councils. Would like Council to be aware of this matter at this time.

Rob Collins - Ratepayer - referred to Section 3 of Community Survey concerning rate charges going up or down. Spoke to maintenance of existing services and backlog. Then spoke to Optus Tower and Council staff clearing up graffiti and repairing fence. Why was Council's money expended on this? Is there a deficiency in Council's leases? Referred to repair of chain wire fence around old Bathurst Bulldog Clubrooms and that the Clubrooms have now been sprayed with grafitti. Reported this to Police, hoped Council will follow this up. When Optus Tower lease is renewed next year competent people need to re-write the lease. Before any rate increases are approved, Council should undertake a review of all asset maintenance procedures.

<u>Gordon Crisp - Ratepayer</u> - spoke to submission under Section 420 of the Local Government Act and that he intentionally included something incorrect in it. Spoke of staff members and issue of declaring an interest in the matter. Made allegations of pecuniary interest against General Manager and Director Corporate Services and Finance and how items should be declared and the legal requirements thereof. Spoke to his submission and allegations regarding superannuation payments owed to him by Council.

The Mayor asked Mr Crisp to resume his seat as he should not be making accusations against individuals.

Mr Crisp - stated Mr Sherley and Mr Roach stole his money.

<u>Bob Triming - Resident</u> - Congratulations to Cr Bourke as Crematorium has started. Thanked Council for works at BMEC on wheelchair ramp and handrails, this is excellent. Merry Christmas to everyone.

Proposed Lot 114 and proposed Lot 115 are therefore below the minimum areas specified by Clause 27 and 28 of the Bathurst Regional (Interim) Local Environmental Plan 2005, in that they will have areas of:

- Lot 115 19.0 hectares

The applicant has submitted a SEPP 1 Objection (see SEPP 1 Objection at <u>attachment 3</u>) in relation to the creation of proposed Lot 114 and proposed Lot 115 which indicates the nature of the subdivision and their objection to the current standards because:

- 1. All lots are already well below the minimum lot size of 200 hectares;
- 2. The proposed lot sizes are consistent with the surrounding pattern of subdivision;
- 3. No new lots are created;
- 4. No new dwelling entitlements are being created; and
- 5. The agricultural use of the lots will not be compromised.

The intention behind the development standards is to limit new dwelling entitlements on allotments less than the minimum area. The proposed lots already contain dwellings and the agricultural potential of the land is unlikely to be compromised by the proposed boundary adjustment.

Concurrence

The variation to the development standard does not require concurrence of the Department of Planning as it does not seek any additional dwelling entitlement.

Need for Council Concurrence

In accordance with the Department of Planning's circular PS08-014 "Reporting Variations to Development Standards", all Development Applications where there is a variation to a development standard of greater than 10% must be determined by Council.

Accordingly this is not a matter that may be dealt with under delegated authority.

Conclusion

1 LOCAL GOVERNMENT AND SHIRES' ASSOCIATION - EXCELLENCE IN THE ENVIRONMENT AWARDS 2012 (16.00103)

Recommendation: That the information be noted.

Report: The Local Government Excellence in the Environment Awards were initiated by the Local Government Association and the Shires Association (LGSA) of NSW in 1998. Held annually, the awards aim to recognise outstanding achievements by NSW Local Government in managing and protecting the environment.

There are 13 categories which councils may enter and for each of the award categories there are 3 divisions based on a council's population base. Bathurst Regional Council falls into Division B (population 20,000 – 60,000).

Council entered the Water Conservation category for the 2013 awards with a nomination titled "Waterwise Bathurst". The nomination covered 2 important projects completed within the award period, the Supernatant Recycling Project and Manganese Removal Trial.

The supernatant project has maximised water recycling by upgrading infrastructure at the Bathurst Water Filtration Plant. Modification of the sludge lagoon outlets has enabled supernatant (treated water) to be piped back to the inlet mixing tank rather than being discharged to the Macquarie River.

A Manganese Removal Trial has been undertaken to improve the quality of water entering the network and reduce volumes of water being wasted through reactive mains flushing. There are few effective measures for treating manganese once it enters the reticulated network; however the results received from the Stage 1 and Stage 2 trial have been very positive.

Council was successful in winning the Water Conservation, Division B award. The Manager of Water and Waste made presentation detailing more information about the nomination and both projects, this presentation was well received.

Council also entered the Communication, Education and Empowerment category for 2013 with a nomination titled "Bathurst Backyards for Wildlife Booklet". As the title suggests the nomination related to the production of the Bathurst Backyards for Wildlife Booklet, which was prepared by Council's Environmental Officer.

The booklet provides detailed guidance to local residents on creating habitat for wildlife within their own backyards, whether large or small. It includes extensive lists of recommended flora species and an explanation of various types of habitat for fauna.

The booklet is free to download from Council's website and is available to purchase in hard copy for \$3.00 from the Civic Centre and Library.

2 CENTRAL WEST CATCHMENT MANAGEMENT AUTHORITY GRANT FUNDING - WATER SENSTIVE URBAN DESIGN PROJECT (16.00133)

Recommendation: That the information be noted.

Report: In December 2012, Council was successful in securing funding from the Central West Catchment Management Authority and Salinity and Water Quality Alliance (CMA) to undertake a Water Sensitive Urban Design project.

The amount of \$20,000 was secured from the CMA to complete Stage 1 of a proposed 2 stage project to be undertaken along the Hope Street side of the Bathurst Adventure Playground.

Stage 1 of the project would centre on the design and implementation of up to 6 individual bio-filtration beds which at this stage would be located between the existing mature street trees at the top end of Hope Street. The location of these bio-filtration beds would visually complement the existing street tree planting, not compromise the existing root structures of these established trees and allow for access into the playground. A key objective of the project is to enhance the park amenity, and the design will ensure that the existing elements continue to work and that there is no restriction on future enhancements to the park.

The purpose of the bio-filtration garden beds is to improve the quality of stormwater run off coming from Hope and Howick Streets. As significant amounts of water move over the grassed areas of the Adventure Playground during rainfall events, primary filtration of any stormwater run-off in this area will improve the quality of those flows eventually entering the Macquarie River.

At this time there are very few examples of Water Sensitive Urban Design (WSUD) in place across the region and as a result Council wishes to undertake this pilot project which could showcase the potential effectiveness of WSUD and demonstrate how a well planned maintenance program could ensure the ongoing success of such a project with minimal impact on Council resources. The amenity of park users has been considered and the minimisation of the potential impact on access or parking is a key design consideration.

Under Stage 2 of the project, Council is proposing to design and construct a fully functioning bio-retention swale at the lower end of Hope Street which will build on the existing filtration processes operating within the Stage 1 bio-filtration beds and provide further filtration for stormwater run-off along the length of Hope Street.

Stage 2 of the project would also incorporate the installation of an appropriate water collection tank which would be connected to the bio-retention swale enabling filtered stormwater to be harvested and stored for use in toilet flushing in the public amenity block located at the lower end of Hope Street.

The design for Stage 1 has been commenced by staff within the Technical Services Section. This, and all future designs will be developed in conjunction with staff from the Recreation Section to ensure that the works enhance the current visual and operational amenity of the Adventure Playground.

<u>Financial Implications</u>: Covered in existing budgets.

3 NSW GOVERNMENT RESPONSE TO INFRASTRUCTURE NSW STRATEGY (03.00030)

Recommendation: That the information be noted.

Report: In July 2011, Infrastructure NSW was tasked with preparing a 20 year Strategy that assessed the current state of infrastructure and identified strategic priorities for the future.

The Strategy is independent advice to the NSW Government on the specific infrastructure investments and reforms recommended to make NSW number one again.

The Strategy looks across a broad range of sectors and identifies specific projects and programs for priority consideration. It also makes recommendations to the NSW Government on how to fund these recommendations and was released on 3 October 2012.

On Thursday 13 December 2012, the NSW Government released their response to the 70 recommendations, with full details at http://www.nsw.gov.au/sites/default/files/pdf/Government-Response-to-INSW.pdf

Of particular relevance regarding the operations of local water utilities is the following recommendations & responses, especially recommendation 52, which are taken directly from the Government response document:

Recommendation 52

Merge regional water authorities from 105 to around 30.

Infrastructure NSW recommends the various key conclusions for changes to regional water supply arrangements be considered, including aggregation of (from 105 to around 30 authorities) water and wastewater delivery authorities.

<u>Implementation Timeframe</u>: Short Term (0-5 years)

Government Response: Supported.

The NSW Government is currently considering options to improve the efficient delivery of high quality drinking water in regional areas. The Government will develop options in conjunction with the review commenced in March 2012 by the Minister for Local Government into local government structural arrangements. A preferred model will be developed in consultation with local councils. The Local Government review will be completed in mid 2013.

Recommendation 53

Water and wastewater upgrades in regional towns to meet national standards.

Infrastructure NSW recommends a prioritised program of work is undertaken across Regional NSW to bring water and sewerage systems up to required minimum drinking quality and environmental standards.

Implementation Timeframe: Medium to Long Term (5-20 years)

Government Response: Supported.

Although ensuring local utilities meet relevant standards is primarily a matter for local government, the Government recognises the continuing need to upgrade water and sewerage systems in regional towns to meet national water quality and environmental standards. The Government will undertake a cost benefit analysis of the required infrastructure upgrades and develop a prioritised program of works by the end of 2014.

Recommendation 54

Regional dam construction and safety upgrades.

Infrastructure NSW recommends the development of a comprehensive, prioritised program of new and refurbished regional dams throughout NSW to address the impacts of climate variability and drought scenarios.

<u>Implementation Timeframe</u>: Medium to Long Term (5-20 years)

Government Response: Supported.

NSW is currently investigating current water supply in regional areas and the need for new projects to augment current supply levels. This work is being undertaken with consideration to other reviews in this portfolio area, including the Dam Safety Act review and the Legislative Council Inquiry into the adequacy of water storages. Consideration will also be given to broader national reforms including the National Water Initiative and the Murray Darling Basin Plan. Based on these investigations, options relating to dam infrastructure will be developed by the end of 2014, including water supply and flood mitigation functions.

Action Taken

Following the issuing of the NSW Government response to the Infrastructure NSW Strategy, Council wrote to the Premier, along with the Member for Bathurst, the Minister for Regional Infrastructure and Services, the Minister for Primary Industries, the Minister for Local Government and the Minister for Western NSW to ensure that they are aware that Council's adopted position in regards to merging regional water authorities from 105 to around 30 is that the status quo should remain and that Bathurst Regional Council must stand alone. Council also requested their acknowledgement that Council meets all the requirements of the status quo model.

Further details are available in the reply letter, which is provided at attachment 1.

Council will be kept informed on future developments in this area.

4 LOCAL LAND SERVICES - PROPOSED NEW BOUNDARIES (07.00047)

Recommendation: That the information be noted.

Report: From January 2014, Local Land Services will deliver functions currently provided by Catchment Management Authorities and Livestock Health & Pest Authorities and agriculture advisory services of Agriculture NSW, part of the Department of Primary Industries.

An independent Stakeholder Reference Panel, was established to work with community and stakeholder groups to identify how the new organisation will best deliver valuable services to the people of rural and regional NSW. The Local Land Services Stakeholder Reference Panel has released a final draft of regional boundaries for the new organisation after inviting feedback from stakeholders on a draft boundary proposal. Council responded to the initial proposal which included Bathurst in a large region that extended South all the way to the Victorian border.

In December 2012, the Local Land Services Reference Panel agreed on a set of administrative boundaries for 11 Local Land Services shown in the map at <u>attachment 1</u>. In mid January 2013, Council subsequently received correspondence indicating that the Reference Panel may still consider further well supported submissions up until the time of the consultation workshops.

The proposed boundaries will attempt to align regions with broad landforms and land-use to best match biophysical form, land use and management. Also, the boundaries have been selected to align regions with specific local government area boundaries to help deliver efficient services and better outcomes for their communities.

Further consultation on the boundaries, as well as other key features of Local Land Services including governance structures, core functions and the rating framework, will also take place in community consultation workshops planned for February and March 2013. The Bathurst consultation workshop is scheduled for 12 February 2013 to be held at Bathurst Panthers, 132 Piper Street, between 8.00 am - 11.00 am. Background information will be made available for participants via the Local Land Services consultation website: haveyoursay.nsw.gov.au/locallandservices, ahead of the workshop.

Following these planned consultation workshops, recommendations on key features of the new Local Land Services will be made to the Minister for Primary Industries.

Council will be kept informed of major developments.

5 WEIGHT OF LOADS GROUP (07.00030)

Recommendation: That Council:

- (a) withdraw from the CENTROC Weight of Loads Group effective as from 30 June 2013;
- (b) support the Weight of Loads Group Management Committee resolution that the Group be wound up by 30 June 2013.
- (c) review alternatives for control of heavy vehicles on local roads.

Report: Council is currently a member of the CENTROC Weight of Loads Group which was established in 1995 with a total of 8 Councils. The purpose is to inspect and provide enforcement of heavy vehicles on the roads in the Bathurst area to reduce the damage to local roads as a result of overloaded vehicles and prevent the utilisation of load limited roads by inappropriate vehicles.

At its peak the group had 12 member councils, but the current membership stands at 7, including:

Wellington Council (administering Council)
Bathurst Regional Council
Blayney Council
Dubbo City Council
Gilgandra Shire Council
Orange City Council
Weddin Shire Council

Both Gilgandra Shire and Weddin Shire Councils have advised of their withdrawal from the group and Orange City Council advised the Annual General Meeting that it would not be continuing membership beyond the 30 June 2013.

Wellington Shire Council is also currently considering their position in the continuation with the group.

Bathurst Regional Council's contribution to the operation of the group in the current financial year was \$34,963 which would substantially increase with the reduction in membership and further fragment the already geographically diverse group.

At the recent Weight of Loads Group meeting it was considered that the most appropriate course of action would be to wind up the group at the end of the financial year with any remaining funds to be dispersed between Councils.

This Council's alternatives for the control of heavy vehicles on its network include:

- 1. Consider applying to the South East Weight of Loads Group for inclusion into their operations.
- 2. Seek support from the Roads and Maritime Service for enforcement on Council's local roads on a user pays basis.

It is considered that the group is no longer viable and Council should withdraw from the group effective from the end of the financial year.

1 VILLAGE IMPROVEMENT PROGRAM - TRUNKEY CREEK COMMUNITY HALL (16.00104, 18.00223)

<u>Recommendation</u>: That Council allocate \$4,638.04 to the upgrade of the Trunkey Creek Community Hall fire doors, emergency exits and associated works from the 2012/2013 Rural Village Improvement Program funding.

Report: Council staff recently undertook an inspection of Village Improvement Projects at Trunkey Creek. The Trunkey Creek Progress Association have acquitted their grant making good use of Council funds to install a fire door in the kitchen, concreting stall areas and purchasing refrigerators under the 2011/2012 Village Improvement Program.

During the inspection of this program it became evident the fire doors within the main hall, emergency exits and associated signage at the Trunkey Creek Community Hall were substandard, not meeting the legislative requirements or providing suitable levels of security to the community, thus effectively threatening the ongoing operations and insurance coverage of the facility.

Council has arranged for all defects to be rectified.

No funding has been allocated for rectification maintenance for this facility and works were unable to be deferred. Staff consider it appropriate that surplus funding in the Village Improvement Program be utilised in this instance as the works fit within the Village Improvement Program criteria being located in a village and infrastructure upgrades for community use.

<u>Financial Implications</u>: Funding for rectification/maintenance works for the fire doors, emergency exits and associated signage has not been included within the current budget. These works may be funded from the Village Improvement Program, having a net effect of zero on Council's budget. The balance available of these funds is \$16,468. Project cost is estimated at \$4,638.04.

2 COMMUNITY LANGUAGE LIBRARY MATERIAL (21.00054)

Recommendation: That the information be noted.

Report: Bathurst residents from Multicultural backgrounds are able to obtain reading material in Languages Other Than English (LOTE) as they can borrow books and audio books from the State Library Multicultural Service through Bathurst public library. This service is provided free to public libraries by the State Library and is a suitable alternative to Libraries purchasing small ineffectual collections in LOTE.

In December 2012, Bathurst Library had books on loan from the State Library in the following LOTE: French; Swedish; Persian and Chinese. Other languages borrowed during the year for Bathurst residents include: Thai; Polish; Bengali; Punjabi; Japanese and Italian.

Books are delivered in a box, containing some 30 to 40 books, so a decent selection may be made. The contents of each box can be made up to the borrowers specification, for example, adult books only or fiction only etc.

The Multicultural Service collects books in over 40 community languages including English as a Second Language. The collection includes:

- Adult fiction;
- Adult popular non-fiction such as history, poetry and drama, cookery, medical information:
- Resources for children such as picture books, nursery rhymes, bilingual books and sound recordings.
- Large print and audio books in some languages are also collected.

This service provides an effective and adequate level of access to reading material for those in our community with English as a second language and allows the Bathurst library to concentrate on purchasing material in English.

Financial Implications: There are no financial implications resulting from this report.

Report: On Saturday, 1 December 2012 the Bathurst Library hosted the very first Christmas on Keppel; a community fair in the Library courtyard. Businesses from Keppel Street and Library sponsors were invited to hold a stall at the fair, or provide entertainment. The fair was designed to promote both the library and the Keppel Street shopping precinct.

There were 13 gift stalls including: Library shop and book sale, Gallery shop, The Naked Bud retro goods; Salvation Army and St Vincent de Paul; Vanessa Pringle Floral Designs; Frank Smith Work Clothing; CWA; BooksPlus; Primrose Vintage Lace & Trims; Lyndal Tuckey; Mitchell Conservatorium of Music; and the Australian Fossil & Mineral Museum.

Activity stalls included: Fiona Howle Creative Workshops making Christmas bunting and tree hangers; Fairy Dust Face Painting; and the Australian Fossil & Mineral Museum had fossicking for gemstones.

Live music was provided by the Mitchell Conservatorium of Music with their Jazz Band & Young Voices Choir. SACK Music provided 2 solo performers; Kate Meadley and Kaylee Bell, and the fair also had a Saxophone busker, Saxon Nichols.

Food for the event was provided by Bathurst Library's sausage sizzle, cold drinks and lollies, as well as an Annie's Ice Cream stand.

There were approximately 2,000 people in attendance throughout the event which ran from 11.00am to 3.00pm. Both stall holders and members of the community provided the Library with positive feedback about the event.

The Library is considering running the event again next year, and will be working with participants to get input into style content and format. Staff are very conscious that the event consumed a large amount of resources and the ability to meet this demand will be a critical consideration in the event proceeding again.
