#### INTRODUCTION

## What is a Conservation Management Plan

An important tool in caring for a heritage item can be a conservation management plan (CMP). This document provides a guide for future care and use, including any new development. Dr James Kerr describes a CMP as "...a document which sets out what is significant in a place and, consequently, what policies are appropriate to enable that significance to be retained in its future use and development. For most places it deals with the management of change" (Kerr, The Conservation Plan, National Trust NSW, Sydney 2000: 1).

### Location and property description

Lot 1 DP 1119065 and Lot 1 DP 1118772, Sofala Road, Peel. Parish of Peel, County of Roxburgh.

Peel Cemetery is located approximately 20 kms north of Bathurst, and 2.5 kms south of Peel on the Sofala Road and 2 kms south of Peel.

#### Method

The method used in this study is based on the Australia ICOMOS 1988 Charter for the Conservation of Cultural Significance (The Burra Charter); Conservation Management Guidelines and Heritage Assessment by the NSW Heritage Office and Department of Planning 1996; NSW Heritage Manual and James Semple Kerr's 'The Conservation Management Plan' printed by the National Trust of Australia, NSW.

## **SUMMARY & RECOMMENDATIONS**

#### Summary:

A small cemetery on approximately 2 hectares representing the Catholic and Anglican residents of the settlement of Peel and surrounding rural districts.

Located in an area of light bushland, the cemetery is located approximately 2 kms from Peel, and accessed via a private road over private land.

The oldest extant monument is a most unusual cross formed from pieces of slate laying flat on the ground, in three parts. This monument is dedicated to two Suttor children.

#### **Recommendations:**

#### 1. That Bathurst Regional Council adopt this CMP.

#### 2. Develop a site management plan.

Include implementation of the study recommendations from Part 8 of the Bathurst Regional Heritage Study 2007, and the site specific recommendations developed as part of this CMP as follows:

- **Repairs to monuments**: Draw up a schedule of conservation work highlighting the most urgent works. Refer to the Inventory 1 of memorials contained in this document, and to the 'condition' column for specific works.
- **Site Works**: In the vicinity of memorials, remove or cut back trees or shrubs that are adversely affecting any particular grave site.
- **Fencing:** The existing fence is in good repair. Generally repair the swing of the main gate.
- **Interpretation:** Consider interpretation information including:
  - 1. A sign at the cemetery gate with the cemetery name and listing known burials of up to approximately 50 years ago, and a brief history.
  - 2. Consider making available interpretation materials in printed form or information on Council's website.
  - 3. A seat or place of rest, near the gate sign.
- **Maintenance:** Draw up a program of maintenance. Adopt appropriate weed control measures. Where existing maintenance of monuments is occurring, encourage the continuance of this maintenance.
- **Documentation:** Document all new works and conservation works.
- **Staff resource**: Encourage Council to allocate a special officer who has an interest in the preservation of cemeteries, whose role should be to oversee the care

- and maintenance of rural cemeteries while encouraging local community groups and/or descendants to assist.
- **Biodiversity**: Biodiversity for this cemetery has been assessed. An additional fauna survey could be conducted.

#### 3. Re-Zoning:

The rural cemeteries in the Bathurst Region are zoned 1(e) Outer Rural. Therefore rural uses of the cemeteries are permissible under the LEP, providing they will not have a detrimental effect on the cemetery.

It is recommended that the zones of the cemeteries be zoned as *SP1* - *Special Activities*, under the future Comprehensive LEP. This would ensure that the zone will assist in the conservation of these cemeteries by restricting the potential development on that land.

#### 4. Listing:

Peel Cemetery is not presently listed. It was recommended to be listed as a heritage item on the 2009 Comprehensive LEP, and this recommendation is endorsed by this CMP.

The Peel Cemetery is listed by the National Trust of Australia. This listing was approved on 18<sup>th</sup> January 1988. Although this listing has no statutory power it is an important listing as it indicates its value to the community. The reason given for the listing is:

The poignant verse on the memorial to the three Suttor children is evocative of the social impact of infant mortality in 19 Century rural Australia. The Suttor families were prominent early settlers in the area and this importance is reflected in the substantial marble obelisk. The relatively small number of monuments in such a large site, the attractive iron gates and other iron work, as well as the finely inscribed slate monuments are noteworthy elements.

#### **5. Community Consultation:**

Local members of the Peel community, and/or descendants of those buried at Peel Cemetery, should be encouraged to comment on, or add to, this CMP.

## PART A - INVESTIGATE SIGNIFICANCE

## **Physical Description**

The area containing the cemetery is an area of approximately 2 hectares of light bushland, located on the corner of an area that once formed the Peel Common.

The cemetery is located approximately 2 km from Peel, and the original road that was designed to access the cemetery from the main road has not been formed. Instead access is via a road over private land which still leads to the entry, in the south western corner of the cemetery.

To the south and west of the cemetery the landscape is cleared, across to the property named *Brucedale*. In the easterly direction the bushland is quite dense and the view corridors do not extend any distance.

Throughout the cemetery there is a scattering of trees, mostly Eucalyptus and some pine trees, with many remnant funerary plantings associated directly with the memorials.

The main layout of the cemetery is based on the original division of the cemetery into the Church of England section and the Catholic section. The fenced area now known as the cemetery is estimated to only contain these two sections.

The remaining headstones throughout the cemetery are distributed. The Anglican, (Church of England), section to the west is centered around the Suttor obelisk and associated graves. In the east, the Roman Catholic section features a number of more modest grave plots, including the large family grave of the Dempsey-Wilson family.

The cemetery is not marked with any signage either at the site or on the passing road.

The sketch below by Barbara Hickson illustrates the general layout of cemetery and graves.




Figure 2: The general layout of the Peel Cemetery, (Barbara Hickson).

#### **Parish Maps**




Part of the parish map of 1895, in Figure 3, illustrates the cemetery on the small square near the bottom of the image.

This was part of the Temporary Common land. The cemetery was to be accessed via land owned by Richard Sadler. The cemetery was dedicated on 31<sup>st</sup> December 1878.

Figure 3: The 1895 Parish map illustrating the location of the cemetery in relation to the Peel village. The original Parish map in Figure 4below, illustrates the cemetery layout which provided for all denominations, and is approximately 8 acres, (3 hectares) in size.

On the parish map there is a lightly hatched area of just over 5 acres, (2 hectares). This closely resembles the actual portion of the cemetery that was 'used' and is close in size to the fenced area today.

## Setting and curtilage

The Peel Cemetery is located within a bushland setting on gently undulating land which rises above the Sofala Road. The land slopes from the east to the west.

A natural curtilage is formed to the north and east of the cemetery by denser bushland, a remnant of the days the land was used as a Common. The double fence line in the west forms the curtilage to the western side, and view over pastoral land lies to both the south and east. The cemetery location is therefore both secluded and peaceful.

From the cemetery the traffic of the Sofala Road is too far away to be noticed.

## **Layout and special features**

The layout of the cemetery is best understood when the original layout of denominations is laid over the present plan. Basically the cemetery was planned as a rectangular cemetery running north south. However only the Anglican and Catholic sections appear to be used. It is these two sections that are enclosed by the perimeter fence today.




Figure 5: The above aerial image was provided by Bathurst Regional Council. The cemetery is located to the bottom left hand side of the large area of bushland that generally represents the former Peel Common. The fine yellow lines that indicates the road to the cemetery is visible in the image. Only the lower or southern area of the cemetery is utilised; the Catholic and Anglican sections.

#### Fencing and gates

The cemetery is well fenced with a rural fence, some new and some repaired. The new fence to the east has mesh with two lines of barbwire across the top and it is well maintained. The southern fence line of the cemetery contains the original, severely deteriorated, post and wire fence, left intact, with a new fence built across the front to animal proof the cemetery. Other fences include old post and wire fences in a repaired condition.

The gates of this cemetery are old wrought iron gates, which are no longer on their hinges.

## Monuments and grave sites

The eastern side of the cemetery, formerly the Roman Catholic section, contains many grave beds including some family plots. The largest of the family groups is that of the Dempsey-Wilson family. This large family plot is enclosed with a simple mesh fence. The gravesites are all constructed in a similar manner with terrazzo ledger and up-stand at one end which has fixed to it a marble plaque.

Included in this plot are:

Marjorie Dempsey died 8<sup>th</sup> June 1978 aged 85 years.

Florence Mary Wilson died 17<sup>th</sup> March 1966 aged 82 years, and her son

James Henry died 25<sup>th</sup> December 1960 aged 53 years.

Ida Josephine Dempsey died 6<sup>th</sup> January 1969 aged 87 years.

Percival Dempsey died 14<sup>th</sup> April 1973 aged 75 years.

Teresa Dempsey Annie died 18<sup>th</sup> July 1912 aged 25 years.

Jane Martha Dempsey (death illegible).

James Dempsey died 5<sup>th</sup> August 1948 aged 94 years.

William James Dempsey born 15<sup>th</sup> March 1878 died 15<sup>th</sup> June1940, aged 62 years.

The general range of deaths in this cemetery is from 1912 to 1978 and there are several graves of more recent dates.

The western side of the cemetery the, Anglican side, is dominated by the Suttor obelisk and a cluster of gravestones, stele and other monuments, around the area. There are also some family plots, notably those of Trevitt and Thomson families.

The cemetery was dedicated in 1878. The oldest known grave may be that of Elizabeth Trevitt, who died on 17<sup>th</sup> March 1884 aged 11years. However she is located in a family grave plot which has a memorial headstone that was installed after her death.

The oldest extant monument consists of pieces of slate laying flat on the ground, in three parts, forming the shape of a cross. This monument is dedicated to two Suttor children.

#### At the top of the cross the text reads:

Verse: 'Be Yee sure that the Lord, dear God, did as he that has made us, and not we ourselves, he gave us his only son to save us'.

#### On the cross bar of the cross is the text reads:

To the Memory of: Oswald Leslie Allworth Suttor, born 09.06.1880 died 28.03.1884. Open thy mouth judge righteously and plead the cause of the poor and the needy.

#### Also of:

Philip Francis Suttor born 1882 died 09.04.1884
Perhaps they went ... in their lives
and in their death they were not divided.
Beloved sons of John George and Celia Suttor of Milamurrah.
Died of Diphtheria and Croup.

#### The last leg of the cross has a large amount of text on it which reads:

Dear little Philip thou art gone, thy mother sorely grieves, yet Christ above upon his throne says little children come to me, Little children gone... Past through... a calm and gentle sleep, To wait at heavens open door. No cause for them to mourn our dear little children when they die a home secure in heaven find, and holy angels them supply, the place of father, mother, kin....<sup>2</sup>

Nearby is another very old monument. Again the monument consists of piece of slate or similar lying flat on the ground, with a long verse etched into it that is now difficult to read:

George F. Suttor, born 21.08.1884. 'Come'th home quite and silent, what a long time they had, they are dead and asleep, weep for our love'.

The above monuments are located within a family plot bounded by a wrought iron fence which contains the largest monument in the cemetery. A tall painted obelisk with memorials on a number of faces, dedicated to eleven or more persons.

#### On one side facing south the text reads:

In memory of Pauline Adelaide Clapham born 27.10.1886 died 08.08.1890 also Charles Samuel Camidge Clapham 01.04.1888 died 12.08.1890 dearly beloved children dearly of George and Alice Clapham.

Lilian Augusta Australia Clapham 22.07.1891 29.09.1964.

#### On the western side the text reads:

Henry Edward Grosvenor/Suttor, 3rd son of Thomas Charles and Mary.

#### On the northern side

Sacred to the memory of Charles Thomas Suttor of Mt Grosvenor born 13.01.1804 died 28.10.1889 and of Mary Grosvenor/Suttor born on Sunday 07.11.1808 died on Easter Day 21.04.1889 and of her son John George Suttor born 07.09.1841 died 28.04.1887.

Verse: 'The Lord is my shepherd I shall not want, he make'th me lie down in green pastures, he led'th me beside the still waters'.

Beneath the top part the next step of the monument forms a memorial to Celia Ann Suttor wife of JG Suttor and their three sons Oswald, Philip and George. The monument is by J. Burns of Bathurst, and appears to be of finely rendered sandstone.

Another grave stone that is one of the oldest in the cemetery is that of John Owens, who died 9<sup>th</sup> January 1886 aged 69 years. This small marble stele is a very modest monument.

## **Inventory sheets**

A description of most of the grave plots or headstones is included at the back of this CMP. Refer to Inventory 1, for more detail and for a condition assessment.

#### **Monumental masonry**

The mason responsible for the slate cross described above is unknown; however the mason for the obelisk is J. Burns of Bathurst. J. Burns also made other monuments within this cemetery as did J. Thompson.

It is a small cemetery in terms of the number of memorials but the slate cross and the obelisk make it of considerable interest.

## Biodiversity: Plantings and fauna

The cemetery as noted above is an area of bushland on the edge of the former Peel Common. A survey of the site in September 2003 by staff from former Evans Shire Council recorded the following information about the plants in the Peel cemetery:

Structural formation class: Woodland – Open woodland.

<u>Dominant Eucalypt Species:</u> Yellow box, (Eucalyptus melliodora), Red stringy bark, Blakely's Red Gum, Angophora floribunda.

Shrubs: Box leaf wattle, Pink and white heath, Hibbertia?,

<u>Ground covers:</u> Hardenbergia, (Happy wanderer), Lomandra, Dianella, Cheilanthes austrotenuifolia.

Weeds: Pasture weeds.

<u>General health or condition of remnant:</u> Grazed open woodland, some ploughing in south eastern corner, pasture species on edges. Mature trees.

Management Issues: Grazing and pasture weeds.

Overall Conservation Asset description: May be medium.

<u>The recommendation for future management are:</u> Need to assess later in spring for any significant forbs, unlikely.

## The Biodiversity Conservation in the Sheep-Wheat Belt of NSW June 2007 survey

was carried out by the Department of Environment and Climate Change (DECC), to assess the status and extent of endangered ecological communities and threatened birds and other fauna across NSW sheep-wheat belt. This cemetery was included in this study (ref No, 1103A), on the 11<sup>th</sup> December 2006. Other cemeteries included were Rockley, Sofala, and Trunkey Creek General Cemetery.

The survey provides a Habitat Complexity Score and notes that: 'A greater habitat diversity = higher score = more fauna species' **This cemetery site recorded a score of 5.** Although this is not a high score, it is still possible that this is an important place for native birds and other fauna. It does indicate a good ground cover layer.

The results of this survey were similar to the other cemeteries noted above. The detailed report is attached at the end of this CMP. Reference to it for more information on ground-layer species. For example the dominant ground cover is Kangaroo Grass and Themeda triandra.

**Fauna Survey**: A 20 minute fauna survey was recorded at the time, of the site inspection for the above survey, within the cemetery and within its vicinity. The principal birds

recorded were Crimson Rosella, Dollarbird, Eastern Rosella, Galah and Noisy Miner. Naturally the timing of this survey may not have maximized the potential results. An early morning, sunrise period would be best for such a survey.

In the future an additional survey of fauna could be carried out using the following table to record the results:

#### Other Features

No other built features were recorded.

## **Documentary evidence**

Present records indicate 102 burials marked by the memorials in this cemetery and represent approximately 25 family surnames. Mistakes in spelling make it impossible to be exact. There are a number of references to these burial lists which include.

A survey by Evans Shire Council in September 2003 recorded the plants listed in the section above and some black and white photographs from this survey are available on Bathurst Regional Council files.

#### **Registered Deaths**

When the NSW Births, Deaths and Marriages records are checked against the names registered in this cemetery there are some issues. Firstly, Peel does not seem to have been a registry. Deaths were either registered at Bathurst or Wattle Flat.

Secondly, and this is typical, the records are incomplete. Sometimes people registered the death of a person, other times they did not. For example, in the name of Trevitt there are six registered deaths at Bathurst and one at Wattle Flat. Three of those six are buried at

Peel and are the children of George and Harriett Trevitt. The first death of one of their children was registered at Wattle Flat. Therefore, exact locations of burials are blurred because of the place of death, (people were not always buried where they died).

Two other children, whose monuments are at peel cemetery, and whose parents appear also to be George and Harriet, are not registered at all. A detailed search of the official death register, to ascertain just how many additional people may be buried here, would need to be part of a more extensive study, as this is beyond the scope of this CMP.

## Summary of physical description

- This cemetery is located south of the Village of Peel, and was once part of the Peel Temporary Common. It is accessed from the Sofala Road via a track through the property *Brucedale*.
- The approach is relatively easy but is not signposted.
- The cemetery is generally light woodland featuring: Yellow box, Blakeley's gum, red stringy bark Eucalyptus trees and Angophora.
- The outer setting on two sides of the cemetery is dense bushland, a remnant of the Common, and the other sides are open pastoral land.
- The cemetery has a below average biodiversity structure but may be significant for bird communities.
- The cemetery is a General Cemetery and was originally planned to cater for all denominations. In practice it is now a Catholic and Anglican cemetery.
- It has only a relatively small number of monuments, but has a few exceptional examples including the Suttor obelisk and a rare slate cross monument that is prostrate and finely engraved.
- The cemetery is generally unknown to the general public or tourists.
- The cemetery is in fairly good condition with well maintained fences.
- About 45 to 50 remaining legible memorials represent some 102 people.
- The monument dates range from 1884 to the present representing over 120 years of service.
- The monuments face east and away from the entry gate.
- The work of stonemasons J. Burns and J. Thompson are represented at this cemetery.
- The cemetery is still in use.
- The monuments form a historical resource containing much information about the life of the times, where people originated from and how they died.
- The cemetery is especially important to the Suttor family who were important local settlers.

## History

The original site proposed for the Peel Cemetery, as indicated on the 1849 Parish map, was in a different location to the present location. It was located on the south western boundary of the village, on the west side of the Sofala Road.

However the site was later notated for lease to LE Inwood and, later again, was marked for disposal. Just to the north of this site, Lot 1 of Section 13, was set aside for a church.




Figure 9: the 1849 Parish map of Peel illustrating the former proposed location of the cemetery.

In the later Parish Map of Peel the cemetery has been relocated to the opposite side of the Sofala Road, at the southern end of land set aside for the Temporary Peel Common, (refer to Figure 3). This land was given for the use of Peel residents and notified for this purpose on 24<sup>th</sup> December 1861. Adjoining land holders included S. Saddler, Thomas Walker, James Stewart, and George Bayley. A little further away the land was owned by George Suttor of Brucedale. Later this property expanded to include all the land to the south and east of the cemetery.

The Parish map of Peel included a layout diagram of the cemetery, (refer to Figure 4). The catalogue number of this map was, C656. The cemetery was dedicated on 31<sup>st</sup> December 1878.

The Peel Cemetery was an important final resting place to many of the Suttor family. There are at least thirteen Suttor's interred in the cemetery. They include the earliest extant graves. Notable amongst the nineteenth century monuments is an obelisk to the memory of Thomas Charles Suttor of Mount Grosvenor who died 28<sup>th</sup> November 1889, and other members of the family.

Thomas Charles Suttor was the second son of George Suttor who arrived in Sydney in 1800 and was a pioneer settler of the Bathurst area taking up land at 'Brucedale' near Peel in 1822 to 1823. The Suttor family gradually acquired large tracts of land in the Bathurst district and several members of this family became prominent New South Wales country politicians during the latter nineteenth century.

## Peel history by the Bathurst & District Historical Society for the thematic Study accompanying the Bathurst Regional heritage Study 2007.

Although much of the Parish of Peel was occupied by free settlers and assigned convicts by the 1830s, the village of Peel, located on the northern boundary of the Parish by the early surveyors, was not proclaimed until 1847. The name was a tribute to the prominent British statesman, Sir Robert Peel.

While speculators from Bathurst and the nearby Suttor family availed themselves of the opportunity to buy land in the fledgling village, John Howard of *Brucedale* was the first to build and open a hotel; 'The Shearer's Arms', on July 1st 1850. Peel proved to be the ideal location for a public house as it was on the main road between Bathurst and Mudgee and, with the discovery of gold, central to mining operations in the area. Although there were no major gold finds in the immediate neighbourhood, the discoveries on the Turon in 1851 enhanced Peel's prospects as a supply centre. The village prospered accordingly.

By 1852 Peel had hosted its second annual race meeting and established its second hotel, 'The Golden Pippin'. In 1854, Grosvenor Francis opened his flourmill and by 1856 National School opened in Peel, the first in the County of Roxburgh. The first substantial

residence in Peel was probably 'Peel House' built between 1851 to 1856 by Dr Kerr, the 'discoverer' of the celebrated hundredweight of gold known as the Kerr Nugget.

James Read became Peel's first postmaster in 1856 and towards the end of the same year Peel's third hotel was licensed. There are representatives of the Read family in the Peel Cemetery. By 1857, Peel's businesses included two good stores with two more under construction, two butcher shops, two blacksmiths and three hotels. Further commercial services were provided by four shoemakers, six carpenters, a tailor and several dressmakers. A Roman Catholic Church (1861) and an Anglican Church, St John the Evangelist, (1866), provided for the religious needs of the village. Life at Peel in the 1850 to 1870 was enlivened by the rivalry of two local politicians, William Cummings and WH Suttor Senior, who represented different sides of the political fence and were also of different religious persuasion.

From the 1860s until well into the 20th century quartz mining along Clear Creek was a constant source of employment for those living in the district.

## Land history

An original cemetery was proposed on the south western edge of Peel, and indicated in the 1847 Parish map of the village. However this cemetery position was not used and another location was designated for the cemetery on the southern end of the Temporary Common. This cemetery was dedicated on 31<sup>st</sup> December 1878.




Figure 11: The Parish map illustrating the different denominations within the cemetery.

The Anglican, (Church of England), and Roman Catholic portions were the main areas of the cemetery that were used, and today it is this area that is fenced, (refer to Figure 11 below).

## **Management history**

Initially the cemetery would have been managed by Trustees of the various denominations. On one 1931 Parish map the Church of England trustees are noted 1<sup>st</sup> March 1940 to 12<sup>th</sup> July 1952.

From about 1967 the Peel Cemetery was managed by Evans Shire Council until its amalgamation with Bathurst City Council in 2005 and is now managed by Bathurst Regional Council.

## Listings

This cemetery is not listed in any statutory form at the present time. In the recent Bathurst Regional Heritage Study it was recommended for listing as part of the Comprehensive LEP. This study supports that recommendation.

#### **Make Comparisons**

There are many other small cemeteries in the local government area generally associated with past mining activities and their support settlements. These include important reef mining localities, between the 1860s and the early 1900s such as the various sites along the Turon River valley important for gold mining, Sofala, Sally's Flat and Turondale.

Possibly the cemetery most like this cemetery is that of Turondale. Originally a church cemetery it is now a public cemetery, and of great significance to a few families in the district.

## **Summary of history**

- Peel was an important transport node, on the main road between Bathurst and Mudgee, and close by to the Turon goldfields.
- Its principal historic period for the village was from 1847, but this cemetery was probably not in use until the 1880s, and dedicated in 1893.
- The cemetery is still in use after approximately 125 years.
- This cemetery served the general community of Peel, Clear Creek and district.
- Among the oldest memorials are those of two Suttor children; Oswald and Philip who died of Diphtheria and Croup in 1884. Their memorial is a most unusual monument, a prone, and slate engraved cross.
- This cemetery was designed to cater for many denominations, but came to be used principally by two religions being the Anglicans and Catholics.
- The cemetery was originally managed by trustees.
- Records for burials are incomplete and dependant upon legible memorials. Many more people may have been buried here than records indicate. The number of known burials is about 102.
- Some families are especially well represented by the monuments of this cemetery including the families of Suttor and Clapham.
- Two surveys of the cemetery found it to be generally below average in biodiversity but it may be an important place for native birds and other fauna.

#### **ASSESS SIGNIFICANCE**

#### Criteria

Following the Heritage Branch guidelines, a statement of significance is developed by working through the following assessment criteria. (adopted from the Heritage Office CMP guideline):

**Criterion** (a) - Historical Significance - an item or place is important in the course, or pattern, of NSW's cultural or natural history, or the cultural or natural history of the local area.

Peel was a very early settlement north of Bathurst and was settled by the mid 1830s. This cemetery dates from about 1880. The monuments here represent some 102 known people. However this is an incomplete record and many more may be interred here.

**Criterion** (b) – Social Significance - an item or place has strong or special association with the life or works of a person, or group of persons, of importance in NSW's cultural or natural history, or the cultural or natural history of the local area. This might include a local family of note, pioneers, or soldiers.

This cemetery is significant to many immigrants from the British Isles who formed a part of the local community. This cemetery is of particular significance to the descendants of those interred here, including families with many representatives such as, Suttor, Clapham, Dempsey, Inwood, Redding and Trevitt.

The cemetery is important as the burial place of Thomas Charles Suttor of Mount Grosvenor who died 28<sup>th</sup> November 1889, and other members of his family. Thomas Charles Suttor was the second son of George Suttor who arrived in Sydney in 1800 and was a pioneer settler of the Bathurst area, taking up land at 'Brucedale' near Peel in 1822 to 1823.

*Criterion* (c) – Aesthetic Significance - an item is important in demonstrating aesthetic characteristics and/or a high degree of creative or technical achievement in NSW or the local area. Consider the work of the monumental masons.

Notable among the monuments is an obelisk to the memory of Thomas Charles Suttor and other members of the family. In the same area and within a 'family' plot is a most unusual prone slate cross to the memory of two young Suttor children.

*Criterion* (d) – Religious Significance - an item has strong or special association with a particular community or cultural group in NSW, or the local area for social, cultural or spiritual reasons.

The cemetery was predominantly Church of England, (Anglican) and Catholic. A Roman Catholic Church, (1861), and an Anglican Church, St John the Evangelist, (1866), similarly provided for the religious needs of the village. Life at Peel in the 1850s to 1870s was enlivened by the rivalry of two local politicians, William Cummings and WH Suttor Senior, who similarly represented the two religious persuasions and different sides of the political fence.

**Criterion** (e) – Educational or Technical Significance - an item has potential to yield information that will contribute to an understanding of NSW's cultural or natural history, or the cultural or natural history of the local area.

The monuments at this cemetery form an important historical document containing information about the life of the times of people and their family connections, and for family history research.

*Criterion (f)* – Rarity - an item that possesses uncommon, rare or endangered aspects of NSW's, or a local area's cultural or natural history.

The cemetery contains some rare headstones, most notably the slate cross.

*Criterion* (*g*) – *Typical or Representative - an item is important in demonstrating the principal characteristics of a class of NSW's or local areas, cultural or natural history.* The cemetery is in many ways a typical rural cemetery. It is both Catholic and Anglican.

## Statement of Significance

Peel was a very early settlement north of Bathurst and was settled by the mid 1830s. The monuments in the Peel cemetery represent some 102 known people, from 1880, but there may be many more interred here.

This cemetery is significant to many immigrants from the British Isles and is of particular significance to the descendants of those interred there including families with many representatives such as Suttor, Clapham, Dempsey, Inwood, Redding and Trevitt.

The cemetery is the burial place of Thomas Charles Suttor of Mount Grosvenor, the second son of George Suttor, a pioneer settler of the Bathurst area, taking up land at 'Brucedale' near Peel in 1822 to 1823.

A notable monument is the obelisk to the memory of Thomas Charles Suttor and other members of the family and a most unusual prone slate cross nearby in the memory of two young Suttor children.

The cemetery was predominantly Church of England, (Anglican), and Catholic. Two churches similarly provided for the religious needs of the village and life at Peel in the 1850s to 1870s was enlivened by the rivalry of two local politicians, William Cummings and WH Suttor Senior, who similarly represented the two religious persuasions.

The monuments at this cemetery form an important historical document containing information about the life of the times of people and their family connections and for family history research.

The cemetery is located in a sheltered and secluded location within a pastoral landscape.

## **Level Of Significance**

This cemetery is of local significance.


